



Scholarship Application for 2022 Summer Camps

Thank you for your interest in YMCA Camp Timbers for your child. It would be a pleasure to partner with you to make a summer camp experience possible in 2022.

As much as we try to keep camp affordable, the cost of meals, lodging, activities, and staff for a full camp session adds up quickly. Thankfully, we have income-based scholarships available to help ensure no child misses out on camp for financial reasons. The Saginaw YMCA's Annual Campaign and the generous gifts of individuals, community partners, and businesses make these scholarships possible.

To apply for a scholarship:

1. Use the chart below to find **the percentage you'll pay**, based on the **Tier A** rate. The remaining cost of camp is supported by scholarship funds donated by individuals, businesses, or organizations.
2. Please complete the attached "Household Application" as a way to document your income. This form may allow camp to receive partial funding for the meals we serve and helps us spread our scholarship dollars to help more campers. If you choose to not use the "Household Application," please e-mail Timbers@SaginawYMCA.org to request an alternate form to submit with your scholarship request.

4. After reviewing your forms we'll call to confirm the scholarship. At that time, a **\$50 non-refundable deposit** is due for each camper to complete their registration. You may send a deposit check with your forms, or pay by credit card on the phone. The **remaining balance is due by May 15th, 2022**.

TIER B - A partially subsidized rate representing \$50 of scholarship assistance needed.

TIER C - A subsidized rate to allow camp to be possible for as many as possible with \$100 scholarship assistance.

A \$50 non-refundable deposit for each camper is due at the time of registration. This can be transferred to another camper or session in 2022 only. The balance is due by May 15, 2022.
