



Scholarship Application for 2020 Summer Camps

Thank you for your interest in YMCA Camp Timbers for your child! It would be a pleasure to partner with you to make camp possible in 2020.

As much as we try to keep camp affordable, the cost of meals, lodging, activities, and staff for a full camp session does add up. To apply for a scholarship:

2. Please complete the attached "Household Application" as a way to report your income. This form allows camp to receive partial funding for the meals we serve and helps us spread our scholarship dollars to help more campers. You may send a deposit check with your forms, or pay by credit card on the phone. The remaining balance is due by June 1st, 2020.

This doesn't include specialty camp programs, horse rides, or camp store purchases. These may be added, but are not eligible for scholarship support. Discounts, including multi-child savings or member savings, are not available with scholarships.

Scholarships are available as funding allows. We encourage families to apply as soon as possible due to the number of requests we receive. The deadline for scholarship applications is June 1, 2020.

A \$50 non-refundable deposit for each camper is due at the time of registration. This can be transferred to another camper or session in 2020 only. The balance is due by June 1, 2020.
