

FREQUENTLY ASKED QUESTIONS SUMMER 2020 PROGRAM CANCELLATION

Is YMCA Camp Timbers open?

At this time, YMCA Camp Timbers is closed. Currently, all summer camp programs are cancelled impacting those camps, trips, and events scheduled now through July. A video message from our Camp Director, Brian Miller, is available here: <u>Summer 2020 Cancellation Announcement</u>.

We will continue to monitor the changing circumstances and follow to guidance from the American Camp Association, Y-USA, CDC, and other national, state, and local health experts to determine any additional cancellations that may be necessary. The health and safety of our campers is always our top priority. As it is safe and responsible to do so, we will reintroduce programs and operations.

This closure only pertains to YMCA Camp Timbers, based on what we believe to be best for our specific camp community. We recognize that camps vary a great deal in their programs, staffing, facilities, and communities served and each has a wide variety of factors to consider. For these reasons other camps may reach different decisions about what is best for, and possible with, their camp community.

Why can't camp be delayed until later in the summer?

Based on current recommendations and guidelines camp programs this summer would be drastically different from what our campers know and love. Recommendations for social distancing, limiting group size, avoiding the use of shared equipment, and PPE availability and usage would make camp unrecognizable this summer. At this time, we don't feel comfortable that we can meet these new needs in the safe and thorough manner our campers deserve this summer while also maintaining our high-quality impactful and fun programming.

If the situation improves, is it possible to have camps yet this summer?

Unfortunately, due to the amount preparation needed to prepare our facilities, programs, and staff for summer camp we are not be able to reverse this decision mid-summer.

As the situation improves, we anticipate offering new opportunities at camp as it is safe and responsible to do so. While these won't replace the experience of summer camp, we hope that we can still offer families ways to enjoy camp in other meaningful ways by late summer.

What happens to my payment?

We are offering several options for families regarding payments they've already made. While we hope families will be able to apply this as a credit to a future program, we certainly understand if a refund is necessary. Each family can share their preference at: 2020 Payment Request.

For our campers currently enrolled in 2020 summer programs, we are offering several options for the fees already paid:

- 1. **Credit towards a 2021 Camp**: For those who do so we will honor our 2020 rate for next year, which avoids likely annual rate adjustments. Dates for 2021 will be finalized later this summer.
- 2. **Donation to YMCA Camp Timbers:** As a non-profit (501c3), the YMCA of Saginaw relies on the generosity of families, organizations, and businesses to support our operating expenses and subsidize the cost of camp for our families. Your support will help ensure the continued operation and upkeep of camp through 2020.
- 3. **Refund of 2020 Payment:** If none of the above options are feasible for your family, we will provide a full refund of 100% of fees paid (including the \$50 deposit).

If requested, we'll provide a full refund of all fees paid (including the \$50 deposit). Payments will be refunded to the credit card used for payment or in the form of a mailed check (for cash, check, or money order payments). We will process these as soon as possible, and we anticipate having all refunds returned within the next 30 days.

What if I apply my payment to 2021 but need to cancel or change sessions later?

These are unprecedented times, and we want to be as fair as possible for families. For families who wish to apply their previous payment to 2021, we will honor the offer of a full refund through December 31, 2020 should they need to cancel at a later date. We'll also offer session changes to another 2021 camp program, as always, for no penalty or loss until the final payment deadline for 2021 camp.

One of my children will be too old for camp next year, can I apply their 2020 payment towards a 2021 program for another child?

Yes. Any payments from this year that are credited towards 2021 will be applied to your family account balance. This will be available to use for any child in your family.

When can I register for next year?

We will be finalizing our 2021 camp session dates later this summer, as well as our 2021 camp fees. At that time, we will email all previously registered families with an invitation to register, with first priority giving to those families who apply their 2020 camp payment towards 2021. This is going to be really difficult news for my camper. Do you have any advice on how to talk to them about summer camp being cancelled?

Whether 2020 was going to be your child's first summer at camp, or whether they planned on it being their final summer after growing up with us for years, we know it will be difficult as one more piece of tough news after months of cancellations and disappointments. Remember, you know your child best – you are the expert in knowing what they'll need and how to support them. Below, are a few suggestions we hope may help.

We think it's important to let your child know that it's OK to feel upset – sad, frustrated, disappointed – by the news that camp is cancelled. As parents it's tempting for us to want to problem solve or minimize their emotions. It's OK to sit with them, listen, acknowledge their feelings and not offer solutions right away. It's also OK to ask them, "how can I help?" Perhaps they just need some time and space, maybe they'll want to talk about camp memories or hopes, or it may be that they have other ideas.

Can our family visit YMCA Camp Timbers or rent any of its facilities during the summer?

As it is safe and responsible to do so, we hope to provide several options for families wishing to visit camp later this summer. All visits will need to be pre-arranged and scheduled in advance with camp staff, unannounced visits or tours are not possible at this time.

As conditions improve, we hope to develop a variety of paid and low/no cost options for families wishing to enjoy time together at camp.
